Priyanka said: "The announcements they make of 56-inch chest and so much strength and power... show them what is the real power. Tell them that political power is not the power of advertisement.

Political power is about listening to the people. The one who listens to the people is the real Shaktimaan."

During her visit, the Con-

gress leader also held several "nukkad sabhas", and is expected to visit Ayodhya's fam-

ous Hanuman Garhi temple.
